#### 1. Justice BN Srikrishna

He is an Indian jurist and a retired judge of the Supreme Court of India. He was the chairman of Committee for providing Telangana Statehood. He is also the chairman of Financial Sector Legislative Reform Commission. He headed the 10 member committee to make India a hub for International Arbitration. More recently He headed the 10 member committee which proposed Draft Personal Data Protection Bill.

# 2. Justice Vijay C Daga

He is a retired judge of Bombay High court and an expert in tax laws. He has pronounced many important judgements during his tenure on direct and indirect taxes. He is also chairman of SEBI High Powered Advisory Committee on settlement orders and compounding of offences.

## 3. Anil Harish

He is Partner at DM Harish & Co. He is an expert in the field of corporate law. He is involved with several educational and charitable trusts and is the former president of the Hyderabad (Sind) National Collegiate Board, which runs more than 25 educational institutions and has about 50,000 students. He is also Executive Vice President of legal institution like Society of Indian Law Firms. He is one of the most sought after speaker in India in Legal field.

## 4. Justice Roshan Dalvi

She is former Judge Bombay High court. She is a passionate activist fighting for gender equality in public sphere. She recently authored a book "Tangible Justice- Glimpses of a Judicial Life". It is essentially reading for anyone who cares about gender, delay on the courts, alternative dispute resolution and legal culture in India.

## 5. Justice J H Bhatia

He is former Judge Bombay High Court. He was chairperson of Maharashtra State Backward Class Commission.

# 6. Firoze Andhyarujina

He is Senior Advocate Supreme Court. He has appeared in a number of important and landmark cases under the Income Tax Act and is an authority on direct tax laws. He is a visiting Professor at various universities and is a regular Speaker before various Financial Institutions, including Institute of Chartered Accountants. He has delivered a number of memorial lectures all over India.

## 9. Justice JH Bhatia

He is former Judge Bombay High Court. Worked as Registrar Inspection of Bombay High Court and then as Principal Secretary Law and Judiciary Department, Government of Maharashtra.In June 2005 elevated as Judge of Bombay High Court and retired in March 2012. Worked as Judicial Member of Armed Forces Tribunal till March 2015. As per directions of Supreme Court in Common Causes case in 1996, he chalked out plans for the district courts headed by him and got disposed of huge pendency. As Registrar Inspection, with approval of the Administrative Judges and the Chief Justice, he got implemented the same plans in whole of Maharashtra. As a result lakhs of cases were disposed of in 2001 and 2002.
