

ear Friends,

Let me start by once again, expressing our grateful thanks to the Hon'ble Chief Minister of Maharashtra, Shri Eknath Shinde, for so generously sparing time to see me and my Executive Board colleagues. On the occasion of celebrating five decades of the relations between India and Italy, I had the privilege and honour of sharing the platform with the Hon'ble Deputy Chief Minister of Maharashtra — Shri Devendra Fadnavis and the Ambassador of Italy - Mr. Vincenzo De Luca, The Deputy Chief Minister outlined his futuristic vision of infrastructure for the development of Maharashtra which is the nation's growth engine and also recalled EU-Mumbai initiatives, to help make Mumbai a truly world class city. The Deputy Chief Minister also promptly agreed to the proposal of Ambassador De Luca that a sister-city relationship be established between Mumbai and Milan. Acknowledging this proposal, he said that this will be a "win-win situation" for Mumbai which is the financial capital of India and Milan, which is the powerhouse for fashion and high-end engineering products and services.

Daan Utsav

For Daan Utsav 2022, on Oct 7th, Mumbai First collaborated with SPARC to organise a Mental Health workshop for the Mahila Milan, a group of female community leaders in Shivaji Nagar settlement, Govandi.

SPARC's flagship programme 'Mahila Milan' is a network of women from poor neighbourhoods who organised themselves into savings groups. For the last 2 years, this network has been working on health and in the process of understanding health service access challenges in their areas, they understood that health issues are not plain physical but also mental and psychosomatic in nature, and expressed their wish to understand it better.



To try and meet this need in the community, a two-hour-long workshop engaged with 25 women leaders from Mahila Milan on the basics of mental health, recognising symptoms of mental health issues and understanding how it can be embedded into their work in the community. The workshop was conducted by Dr. Shubhada Maitra, Professor at the Centre for Health & Mental Health, Tata Institute of Social Sciences (TISS) & Ms. Ashwini Survase, Project Manager at TISS. The ladies of Mahila Milan had many pertinent questions and views on what they understand as Mental health and how they can deal with and equip themselves to cope with their mental stresses and assist others in the community to do the same.



My tryst with Eklavya: Gandhi Yatra

It is said that Mahatma Gandhi is not a person, it is rather an idea that has been imbibed in Indians. Every individual has a unique perspective about the thought called "Gandhi". One of the interns at Mumbai First, Ms. Madhu Parki got a chance to explore Mahatma Gandhi's journey during her internship at



Mumbai First. She attended the 'Gandhi Yatra' organised by the Blue Ribbon Movement under Eklavya 6.0 on 2nd October 2022.

This yatra started from the library at Mani Bhavan, where all the participants started the day with introductions. They further moved to the auditorium to attend a talk by Meghashyam Aajgaonkar, Chief Secretary, who shared many interesting and rare stories about Mahatma Gandhi related to Mani Bhavan. Then, they walked through the Gandhi Sangrahalaya- a depiction of Gandhi's life journey.

As they kicked off the Gandhi Yatra- a 2 kilometres walk from Mani Bhavan, the very first stop was August Kranti Maidan. Formerly known as Gwalior Tank, and now a place of historic importance, August Kranti Maidan was the place where Gandhi launched the Quit India movement and gave the slogan of "Do or Die" on 7th August 1942. Today, it stands as a Smarak (martyr monument) with a white marble pillar and a lotus on top.

Then the yatra proceeded to Gokuldas Tejpal House where Congress was founded in 1885. Today, it serves as a banquet hall for marriages and other social events. Coincidentally, this is geographically exactly opposite to August Kranti Maidan.

After walking for some distance, they visited Gandhi Book Library, which was also the final destination of this yatra. The birthday celebrations of the beloved Bapu began with a cake cutting ceremony followed by snacks. The day came to an end with each of the participants sharing their perspectives about Gandhi- the person and eternal thought.




Clean Mumbai Project

Is Mumbai still the Economic Powerhouse of India?



The objective is to plan the next steps of implementation & work beyond the Six City Drive to create an impact and bring in change.





G20 in Mumbai

Mumbai First team attended the first official side event of the **Development Working Group under India's Presidency of the G20 2023,** titled Data for Development: Role of G20 in advancing the 2030 Agenda.

This event was hosted in person by India's G20 Secretariat, in collaboration with the Ministry of External Affairs, the Government of India, the Observer Research Foundation, the Office of the Secretary-General's Tech Envoy, and the United Nations Conference on Trade and Development (UNCTAD).

The event was designed as a curtain-raiser for further deliberations on D4D in the DWG during India's G20 Presidency. The session would be attended by participants from various walks of life, including representatives of governments, intergovernmental organizations, civil society and private companies. The themes discussed were -

- Rejuvenating legacy systems: From data to public value intelligence
- Models for the future: Leveraging IoT, Big Data and Al for the SDGs





With a belief that public art has a vital role to play in society, as it creates spaces for dialogue and communication, educates people about visual culture and the arts, provides opportunities for emerging artists, and gives contemporary identities to major cities in India, the St+art India Foundation was founded in 2014. The goal was to bring art out of traditional spaces such as galleries and museums

and into the public realm. Currently, St+Art India project encompasses seven cities across India, focussing on specific localities within the cities.

One of the founders, Hanif Kureshi has been actively involved in the street art community. Meanwhile, Arjun Bahl and Thanish Thomas have a background in events and logistics. Giulia Ambrogi worked as a curator and Akshat Nauriya is a filmmaker and visual artist. They all got in touch during the Khirki Extension street art festival when they found that they were all in six degrees of separation wanting to do the same thing - make public spaces more vibrant and interactive for the people who use them the most, and to make art more democratic as a medium.



That's how their first project took shape in Shahpur Jat.

The team understood that in India, a country this crowded, the streets are where magic happens. Many people come from rural towns in the city, where communication through walls has always been normal. Thus, these people were the first ones to welcome street art in their localities. The concept of 'urban art' was fairly new and the team was finding their way into it. With the vision in mind, after their second project, they established St+art India Foundation.





The idea and journey of introducing art for public spaces in Mumbai by St+art India:

For their first project in Mumbai in 2014, St+art India worked in different areas in the city which inhabit a variety of demographics. From more affluent areas with internationally exposed crowds like Bandra to areas like Mahim East which is predominated by locals, art was showcased to all. The team mentioned that areas like Mahim East immediately connected to the art and welcomed it with open arms and witnessed a lot of community engagement too. Mumbai being the financial city, didn't have that sort of creativity flowing in the regular day to day lives of the people. In 2017, after the first run of the Sassoon Dock Art Project, the team immediately saw the potential of urban art in the city and decided to come up with the second season in 2020 which was further pushed to 2022 due to the pandemic. Their community grew organically over time, fuelling the willingness to build something bigger in Mumbai which brought them the Mumbai Urban Art Festival.

Challenges and obstacles faced by the St+art India Foundation in their movement:

One of the team members of St+art India duly mentioned that the biggest challenge for everyone across the world in the art and culture space is the support and funding and perhaps in India more than in other countries. St+art India team believes that creative industries in the country do not get the right support and recognition it deserves. Unfortunately, the companies and authorities would first use their funds to overcome more pressing issues like children, environment, poverty etc. St+Art believes that art along with other things is a motor of growth. However, it is hard to get the right support amongst other issues. The country currently has very few patrons of art, due to which the push towards making art and culture the main agenda of growth and urban regeneration takes a step back.

Another challenge they have faced in past years is that government bodies get stuck in bureaucracy despite wanting to support such initiatives as anything of this sort has never happened before in Mumbai. This slows down the process and oftentimes does not allow the team to bring our vision to life. The aim of St+Art India Foundation is to make art accessible for all and for that it needs to involve the communities residing in the localities. To be mindful of different aspects of the communities is needed as working with different cultural and social norms can be delicate.







St+art India Foundation shared that they feel grateful they have found partners that share the same vision as they do and get the support that helps achieve their goals. However, since maintaining any culture is novel, they often do not have as many helping hands as they would like. The team is always working long hours and gets less production support.

Encouraging citizen participation and support along with a way forward:

As mentioned by the team, St+art India believes art is for all. They encourage everyone to be a part of this movement in whichever capacity possible. They are always on the lookout for volunteers, students from colleges, children that reside at the dock, art enthusiasts from all backgrounds, anyone and everyone who is passionate about arts. Interested people can reach out to them on social media to get involved. They believe that any support, or even spreading the word would make one the participant of the movement. The team of St+art India is trying their best to adapt to the ever changing landscapes of the city and integrate art within them.
